This process is intended to improve efficiencies, enhance competitive procurement, and manage the procurement risk of the Bank.

BBS Bank will however endeavor to procure goods and services from entities and individuals registered with BBS Bank through this process as and when a need arises over a period of 24 months.

Selection Criteria

The expressions of interest (EOI) submitted will be checked for completeness and compliance with the requirements of this invitation for EOI. The selection will be based on the following:

- i. Completeness and compliance with the invitation.
- ii. Capability and capacity of companies looking at past experience.
- iii. Number and availability of appropriately skilled employees.
- iv. Comparable projects undertaken in the past.

The EOI must be accompanied by the following documentation:

- i. Company or business or partnership profile
- ii. Copy of certified certificate of incorporation or registration of business, as applicable
- iii. Certified copy of trading license, where applicable
- iv. Copy of register of shareholders AND directors or the like as issued by CIPA or equivalent also indicating number of shares held by the shareholders/partners and their nationality.
- v. Certified copies of identity documents for shareholders and directors or partners. In the event a company is a shareholder (shareholder company), a certificate of incorporation of shareholder company accompanied by an indication of shareholding by such company as well as identity documents of shareholders and directors of such shareholder company. If it is a partnership, a signed copy of the partnership agreement evidencing the partnership and shares of the partners in the business.
- vi. Certified copy of valid tax clearance certificate
- vii. Certified copy of any regulatory certificate or certificate of registration allowing the supplier to operate as such, which the supplier is statutorily required to hold where applicable
- viii. Minimum of three (3) reference letters from previous clients
- ix. Proof of physical company premises (Service bill with company address, Lease agreement if company is leasing or title deed if the offices are owned by the company)

Failure to submit any of the above documents will result in disqualification of the bidder(s)
